Mayor Todd called the meeting to order at 7:00 p.m. Present were the mayor, Lynn Reece, Zane Hedgecock, Steve Yokeley, Mark Swaim, and attorney Aaron Clinard. Absent were Gary Craver and Lynn McKinnie – both due to illness.

Mr. Hedgecock confirmed there was a quorum present.

Mr. Reece said a brief invocation after which Mr. Yokeley led the pledge to the flag.

Public Session was opened at approximately 7:04 p.m.

Mayor Todd asked that Gary Craver – due to continuing lung problems - and Lynn McKinnie – due to gall bladder surgery today - be remembered in prayers.

1. Paxton Butler

Candidate for Superior Court Judge in Davidson County

Mr. Butler said our judicial district was split creating a new judgeship in Davidson and Davie Counties. Voters come from those two counties – this is for Superior Court, a very important position. Superior Court judges preside over major felonies, jury trials – they ensure that the laws are followed and that all your

rights are protected. They ensure that each of us have a fair hearing when we end up in the court. He said he has been a district attorney for 10 years now. He began working in Superior Court nine years ago, trying every major felony that can be imagined – including murder cases and child sex cases (which he has been prosecuting exclusively for the past five years.) His experience is in Superior Court and has tried more than 100 jury trials, major felonies – experience which he believes his opponents can not offer. Judges are there to make sure that laws are followed and everybody is held accountable for crimes they commit. Over the past ten years, he said he has seen many judges just slap the wrist of criminal defendants that he has tried to remove for as long as possible. He wants to see that judges in our district that won't protect us or follow the law are not elected. He believes in the "right thing to do". He is committed to running for the Superior Court Judge – it's the right thing to do. He believes in a firm hand when it comes to crime. He asked for the citizens' support. He faces a primary in May – two other gentlemen are running against him. He said he greatly appreciated the time afforded him tonight and the opportunity to speak.

**DISCUSSION:**

Mayor Todd said this was discussed a couple of meetings back. The Winston-Salem MPO submitted their original resolution to the State and it was given back to them with changes to be made (an ongoing process for about six or seven months). At the last MPO meeting, they re-submitted this MOU – what it is doing is adding the Town of Midway into the MPO. It reiterates the voting structure from the Winston-Salem and surrounding members of the MPO. They're trying to work through those issues. Mayor Todd said that basically, everything is the same as before except with the addition of Midway, voting structure, some of the language has been changed – lot of minute changes to it. – nothing that he thought would affect the Town of Wallburg in any way financially or in any other form. He said you will be asked for a contribution from the MPO this year – amount has not been determined but it's usually assessed on population. Wallburg is presently a member of the Winston-Salem MPO and the High Point MPO. Mayor Todd referred to the town attorney for any further updates. Attorney Clinard said Mayor Todd had covered the major changes and that everything else was as before – would require another vote.

1. Planning and Zoning Updates .....Dean Coe  
 Van Reece spoke for the Planning Board. He said there is a rezoning before the Planning Board and will be dealt with this coming Thursday night. They are also working on revising the subdivision ordinances.

2. Finance Update .....Mark Swaim  
 Mark Swaim said with Lynn being out sick, he had to call the banks today to get the information as of today.

He said our budget is due by July 1<sup>st</sup> and the timetable is to vote on the budget at the June meeting. He needs any input or request for the Finance Committee to consider because the committee will start meeting this month. He will get with Lynn to post the information.

3. **MPO - High Point** .....Lynn Reece  
 Lynn Reece said they met on March 25<sup>th</sup>. They want to combine the TAC with the TCC. They voted to run a trial to see if combining the two (both would be meeting at the same time) would work. They're building bridges on Wallburg-

High Point Road. The bridge over Spurgeon Creek was built in 1948 and the one over Abbots Creek was 1949.

Mayor Todd reminded everyone that Mr. Reece is the representative for Davidson County – a great honor that he was nominated for that.

**4. MPO - Winston-Salem** .....Mayor Todd

Mayor Todd attended the meeting. The consideration and adoption of the Winston-Salem Urban Area MPO was brought forth along with the adoption of the Urban Area Human Services Transportation Plan. They considered the resolution certifying the Winston-Salem Urban Area MPO Planning Process, which is what we just did here – was accept that planning process according to recommendation by the DOT and our federal and state government agencies. It has to go through a three or four step process before it is an official document.
