After a brief invocation by Mr. Reece, Mr. Craver led the pledge to the flag.

Dean Coe, Planning Board Chairperson, gave a brief explanation of the purpose of the Watershed Ordinance by stating that the ordinance is the same one in existence in Davidson County for years and years. It is to preserve the ecology and it is something that should be enforced in all counties that fall within the watershed area. This action is just a matter of the Town of Wallburg adopting the ordinance to allow Davidson County to continue enforcing it. He said the Wallburg Planning Board recommends adoption of the ordinance and resolution.

3. JOHN M. FULLER, AIA --- FULLER ARCHITECTURE, INC. PRESENTATION TO TOWN COUNCIL

Mr. John Fuller represents Fuller Architecture and said that he was present at the request of council member Gary Craver. He had planned on giving a short presentation to the council giving information on his company, but due to the tight agenda, he was asked to just briefly state his credentials. He said his company is located in Mocksville and was started in 1992. He handed out a copy of a booklet showing some of his recent projects – among which was a town hall in Yadkinville and an addition to the Troutman Town Hall.

He would be very interested in further discussing the future Wallburg Town Hall and asked that he be considered when Wallburg gets to that point.

Mr. Craver thanked Mr. Fuller for coming and said that we want to get the best that we can for the money and that “the dollar is going to control”.

4. VIVIAN BURGE --- GRANT WRITER PRESENTATION TO TOWN COUNCIL ON GRANT APPLICATION FOR TOWN PARK

Ms. Vivian Burge said at the request of the Mayor, she was asked about the possibility of preparing a grant application for funds for construction of a small Wallburg “recreation area” on the town property. She gave an in-depth presentation on how she would go about applying for a grant and she specifically mentioned the Golden LEAF Foundation funds as a possible funding source. She said she has written many grants, and that a good many of those grants have borne fruit. Her presentation tonight was to be considered an “informational item”. She concluded her talk by saying that her fee is negotiable and that she would want a contractual agreement before proceeding with any grant work.
