**1. Finance Update**

Finance Director Mark Swaim gave a brief update of the town’s finances.

- Checking \$694,853.65
- Building Fund \$940,417.74
- Capital Fund \$250,087.25
- Reserve Fund \$125,620.36
- Money Market \$503,693.19

TOTAL: \$2,514,672.19

**2. MPO - High Point**

Lynn Reece attended the MOP meeting in High Point on September 28<sup>th</sup>, but he nothing about Wallburg was discussed.

**3. Building Committee Updates**

Dwayne Childress updated the council on the town hall building progress, saying the construction was halfway finished – hoping for a late February finish date. The representatives from John Fuller Architect, Kevin, and Kris, requested the council’s approval for the carpet/tile/accessory colors. She gave three choices and the council approved Option #3 – a “taupe/beige” color. Kevin requested the shingle color be approved and the council chose something called “Stonecrest”.
