**MINUTES**

At 7:00 p.m., Mayor Allen Todd called the council meeting to order. Present were the mayor, Steve Yokeley, Zane Hedgecock, Gary Craver, Lynn Reece, Mark Swaim, Jay Wagner, and Lynn McKinnie.

After the devotion by Mr. Swaim, and the pledge to the flag, led by Mr. Reece, the mayor requested adding an additional item to the agenda:

**By motion of Mr. Yokeley, seconded by Mr. Swaim, the amended agenda was approved.**

**On a motion by Mr. Hedgecock, seconded by Mr. Craver the minutes of DECEMBER 14, 2010 were approved.**

**BUSINESS TO BE DISCUSSED AND/OR ACTED UPON:**

**1. NORTHERN DAVIDSON COUNTY CHAMBER OF COMMERCE PRESENTATION**

Mr. Keith Pierce, representing Northern Davidson County Chamber of Commerce spoke to the Council. He told them he was born and raised in this area – Highway 109. He is President of the Northern Davidson County Chamber of Commerce. One of the major benefits of the Chamber is the networking ability – to get your business known to others. He would like to see the Town of Wallburg, as well as individuals, become members. At this time, they have about 140 members and the annual dues are only \$100 per year. They meet the first Tuesday of each month at Center UMC Church in Welcome on Center Church Road. The meetings are lunch meetings and normally start around 12:00 noon. In July, they usually have a chicken stew, and in December, a Christmas dinner. He stated they would like to add more members. Mayor Todd said he would follow up on this issue.

**2. REZONING ISSUE TO BE ACCEPTED/DENIED BY TOWN COUNCIL AND THEN REMANDED TO PLANNING BOARD FOR FURTHER REVIEW**

Mayor Todd asked Dean Coe, Planning Board Chairperson, to speak to this topic.

Mr. Coe said that James and Ruth Brooks have applied for a rezoning at their property on Gumtree Road, near the Shopping Center. They have requested a rezoning from RS, Low Intensity Residential, to O/I, Office and Institutional. According to the Brooks', this rezoning will allow a move from their current communications consulting operation into a larger facility, thus allowing expansion.

Mr. Coe advised the Council that all they are doing tonight is accepting the petitioners' application and then turning the information over to the Planning Board for review at their February meeting. The Planning Board will review the application and forward their comments and recommendations back to the Town Council for a Public Hearing to be held at the February 8<sup>th</sup> council meeting.

Mr. Swaim also said that so far, we have paid everyone connected with the new Town Hall building a total of \$846,532.70.

Lynn Reece said that Dwayne Childress couldn't be here but had submitted a short update, which he then read.

- Amount paid to contractor is \$723,443
- Amount paid to architect is \$98,725.

Mr. Reece said the windows are in on the inside; spray insulation is complete as is stone base. Plumbing and electric rough-ins passed.
