**PROCEDURAL ITEMS**

**CALL TO ORDER**

Mayor Allen Todd called the meeting to order at 7:00p.m. Present were the Mayor, Mayor Pro Tem Zane Hedgecock, Council Members, Steve Yokeley, Lynn Reece, Mark Swaim, and Councilwoman Cindy Johnson. The Town's Attorney, Jay Wagner was present along with Donna Alwine, Town Clerk.

After an invocation by Mr. Donald Dix, Councilwoman Cindy Johnson led the pledge allegiance to the flag.

**MOTION FOR APPROVAL OF AGENDA**

Councilman Mark Swaim moved to approve the agenda with an addition to add, Ordinance # 16-004 related to #2 on the agenda. Also a correction for item #4, Closed Session for a pending legal matter. Councilwoman Cindy Johnson seconded, and the motion passed unanimously with a 5 to 0 vote.

The motion passed with a 5 to 0 vote. Ordinance #16-004 to amend the 2016-2017town budget for the purchase of the property at 8801 N

NC Hwy 109. Councilman Mark Swaim moved to adopt ordinance #16-004, Councilman Lynn Reece seconded. The motion passed with a 5 to 0 vote.

3. Eddie Carrick presented the final audit for the town of the year ending June 30, 2016. The town received a clean opinion. A synopsis of the finances are listed on pages 3-9. Expenses have been consistent, with sales tax increase. Mr. Carrick expressed his appreciation to serve the town and is available anytime for questions or concerns. He appreciates the detailed, hard work of the accounting service, Mr. Jackson.
