MOTION FOR APPROVAL OF AGENDA

- 1. Rebecca Hiatt, 8981 NC Hwy 109, Winston Salem, NC expressed her concerns of break in's that are close in proximity to her home.
- 2. Leigh Gill, 580 Oaklawn Road, Winston Salem, NC ask the council what the plans are for the Wall historic home.
- 3. Elizabeth Boger, 9313 N NC Hwy 109, Winston Salem, NC brought her concerns of security concerns as her home has been broken into previously.
- 4. Principal Sparks, Wallburg Elementary School thanked the council for allowing the student council to hold their meeting at the town hall today. He also requested the property behind the Wall home if that area is ok for physical education to be used on the extended area that joins the school property.

BUSINESS TO BE DISCUSSED AND/OR ACTED UPON:

- 1. Sheriff Grice was in attendance along with his Patrol Major and Chief Deputy. They receive approximately 200 calls a day. Recently increased due to break in's. He read the report of incidents compared to the year past. Encouraged all to call 911 with any suspicious activity immediately.
- 2. Councilman Yokeley updated the repairs on the Wall historical home. Highlights were given from the history of the Wall home significance. Resolution #16-017 to award contract for roof repairs to Independent Project Managers, Inc. not to exceed the cost of \$19,850.00 Councilman Swaim moved to accept Resolution #16-017, Mayor Pro Tem Hedgecock seconded. The motion passed unanimously with a 5 to 0 vote.

- 3. Update on Town Hall Park. Councilman Steve Yokeley advised that the picnic shelters are ready for bid. In this step there will also be including parking lot, utilities and grading. Once those items are ready for bid, they will be placed out for bids.
- 4. The Grants Committee read an application from the Ledford High School Booster Club. They are requesting \$800.00 for their upcoming season for banners to be placed in the softball and baseball fields. This project helps to improve the field and supply the needs of the program. Councilman Mark Swaim moved to accept Resolution #16-016 for the \$800.00 grant request from the Ledford High School Booster Club, Councilman Steve Yokeley seconded. The motion passed unanimously with a 5 to 0 vote.
