**PROCEDURAL ITEMS**

**CALL TO ORDER**

Mayor Allen Todd called the meeting to order at 7:00 p.m. Present were the Mayor, Council Members Cindy Johnson, Lynn Reece, Mark Swaim, Zane Hedgecock and Steve Yokeley. The Town's Attorney, Jay Wagner was present.

After an invocation by Lynn Reece, the Girl Scouts led the pledge of allegiance, which was followed by the Girl Scout Pledge and Girl Scout Law.

**MOTION FOR APPROVAL OF AGENDA**

Councilman Zane Hedgecock made a motion to approve the agenda, Councilman Steve Yokeley seconded, and the motion passed unanimously.

Madison Brown, spoke on behalf of the Cadette Girl Scout Troop in honor of Girl Scout Week. She detailed the various activities for each day to honor the Girl Scout Week.

Kassidy Pennell spoke on behalf of the Junior Girl Scout Troop. She advised that they are working on their Journey Badge and offered their assistance to any community service project to the Town of Wallburg.

1. Mayor Allen Todd recognized the Girl Scout Troop and their leaders. The Mayor read aloud the Girl Scout Proclamation acknowledging Girl Scout Week and presented the proclamation to the troop. This is the only Girl Scout Troup in the Town of Wallburg and they meet at Wallburg Baptist Church. Councilman Zane Hedgecock and Councilman Steve Yokeley commended the Girl Scouts, Girl Scout Parents and Leaders for their commitment and hard work.
2. Mayor Allen Todd called Derrick Huff, with the Central NC Chapter of Multiple Sclerosis Society to represent their cause. Mr. Huff shared information on Multiple Sclerosis and their programs that raise funds for medical research. The Mayor read aloud and presented Mr. Huff with the Proclamation acknowledging Multiple Sclerosis Awareness Week.

3. The Davidson County Master Gardeners previously made a request to the town council for the use the parking lot and the outdoor restroom facilities for the weekend when they hold their annual garden tour. The town’s attorney, Jay Wagner, recommended a hold harmless agreement to be signed for the town’s protection. Councilman Mark Swaim moved to empower attorney, Jay Wagner, to negotiate an agreement with the Davidson County Master Gardeners. Councilman Steve Yokeley seconded and the motion passed unanimously.
