Mark Swaim, the Finance Officer, gave a brief presentation of the proposed 2008-2009 budget, telling the council and audience that the tax rate of \$.05 per \$100 property valuation remains the same as the previous year(s). He attributed this to the Council's conservative approach to "spend less than we earned" and will continue to be the council's plan. The major focus of this year's budget is to fund construction of a new town hall for Wallburg and the Finance Committee predicts that the council should be able co consider construction by the 2009-

2010 budget, but this would depend on construction costs. He said the remaining line items in the budget have remained basically the same as the previous year budget.

Highlights of the budget are:

- Total budget for 2008-2009 is \$640,500.
- Building Fund is \$394,200.
- Davidson County Emergency Services will be \$50,000.

At 7:07 p.m., Mayor Todd asked for any input from the audience – either for or against the budget - no one spoke.

At 7:08 p.m., he then asked for Council input – there was none.

The council expressed their appreciation to the Finance Committee and, Mr. Swaim, in turn thanked his committee, recognizing:

Mayor Todd asked that at any particular time in the future if any changes needed to be made to the budget, would a budget amendment need to be done? That was affirmed by Mr. Swaim, adding that any changes made to the proposed budget would first need to be approved by the Town Council.

1. Planning and Zoning UpdatesDean Coe

Mr. Coe explained that the Planning Board did not meet last month, however, this month's meeting will take place this Thursday evening. At this meeting, they plan on looking at and finalizing the subdivision regulations. Also, they are looking at amending one of the ordinances, which needs to be approved. He said Jack Craven went to a meeting with the County at the Community College for future planning for Davidson County and he will give a brief presentation of that meeting.

3. MPO - High PointLynn Reece

Mr. Reece said that Energy United is supposed to start removing the trees on the town's property next Wednesday.

He gave an overview of the High Point MPO meeting of May 27^{th} – saying they mostly discussed High Point ins and outs. He did receive a pamphlet on what the MPO does, which included:

- Under law, the MPO has to follow certain responsibilities to develop a transportation improvement plan.
- To develop an annual work plan budget;
- To ensure transportation projects comply to federal and civil rights and environmental;

- To ensure the general public is adequately informed regarding transportation decisions;
- To ensure air quality:

The MPO is federal and state funded, but with the federal funding, the municipality has to furnish a percentage of the money furnished by the federal.

4. MPO - Winston-SalemMayor Todd

Mayor Todd said the Winston-Salem MPO has been in limbo for a few months because they are trying to get their draft plan in place but there has been a lot of technicalities that has come up on this issue. The next meeting will be in August. The big issue right now is how funding is designated out to the different areas regarding the Department of Transportation. The MPO does a lot of research in areas to develop long-range planning, but everything has to be done according to federal and state laws – and that's where the issues come up insofar as the long-range plans.
