# **MINUTES**

#### **PROCEDURAL ITEMS**

Mayor Allen Todd called the council meeting to order at 7:00 p.m. Present were Mayor Todd, Council Members Steve Yokeley, Zane Hedgecock, Gary Craver, Lynn Reece, and Mark Swaim. Also present were Attorney Jay Wagner and Clerk Lynn McKinnie.

After a brief invocation by Mr. Yokeley, the Pledge of Allegiance was led by Mr. Reece.

#### MOTION FOR APPROVAL OF AGENDA

Discussion about the agenda was held due to the incorrect listing on the agenda of "Appoint <u>Council Members</u> as Wallburg Board of Adjustment Members". This should actually have read; "Appoint <u>Planning Board</u> Members as Wallburg Board of Adjustment Members".

Also, under the <u>"Regular Monthly and Committee Updates</u>" Mr. Dean Coe has stated there was no Planning and Zoning Updates so this item can be removed from the agenda.

The amended agenda was unanimously approved on a motion from Steve Yokeley and seconded by Lynn Reece.

### DISCUSSION:

This issue is to update the terms of the Planning Board members as well as to dissolve the current Wallburg Board of Adjustment.

Attorney Jay Wagner explained that the proposed move is to merge the Planning Board and the Board of Adjustment into one entity. The functional way of doing that is to essentially abolish the Board of Adjustment and fold it into the Planning Board. He said there are many jurisdictions in the state where the Planning Board functions as the Board of Adjustment, which essentially requires the board members to wear two hats. It works well and is done frequently in small communities. In speaking with other municipal attorneys, as well as other types of attorneys, Mr. Wagner said that most of them actually prefer it that way because it allows all of the folks in small communities to handle all those issues – makes for fewer meetings, etc.

The requirements for Boards of Adjustment and Planning Boards are typically three year terms for each member; however, in creating a new board (which is being done here) then the terms can be set for less than three years in order to "stagger" the terms for members. Mr. Wagner said that the town is combining two boards into one, with very distinctive and different functions; the Planning Board is primarily a legislative, or an "advisory" body.

The Board of Adjustment is considered "quasi-judicial" (with "quasi" meaning "sort of") – so it essentially means that there are some aspects of 'due process" that have to be taken into account for Adjustment hearings. These typically include

- Testimony is provided under oath;
- A record is kept,
- There is a right of cross-examination witnesses at the hearing.
- Also, whatever action BOA takes, there is a right of appeal to Superior Court (there is not for Planning Board).
- No one can practice law without a license so at BOA hearings, people involved have to have an attorney represent them.

He said it might be a good idea if he writes up some ground rules and do some education to make sure that everyone is following the right procedures.

Mr. Yokeley informed the council that, to his knowledge, the Wallburg Board of Adjustment has never met – never made a decision on anything, which is a good thing. The Planning Board, he said, meets at least once a month, plus they have met in quasi-judicial situations. Mr. Yokeley thanked the Board of Adjustment for agreeing to serve on this board.

Mr. Hedgecock asked if the Planning Board heard a case, and there was an appeal, would the same Planning Board have to hear the same case again?

Mr. Wagner said it depends on the type of case – if it's a rezoning case, then the Planning Board will hear that. If a "variance issue" (i.e.: setback for boundary line), then the Planning Board would take off their Planning Board "hat" and put on their BOA hat and function as the Board of Adjustment. Then all of those "due process" requirements apply at that point. He thought a session to set and learn the ground rules would be a good idea.

Mr. Wagner reiterated that the typical term of a Planning Board/BOA member would be three (3) years. There is a term limit – you can serve two three-year terms and then you have to get off for a while. The action taken tonight will in effect dissolve the old board and create a new board.
