1. GENERAL DISCUSSION

As there was no town business to be discussed, the council went right into the monthly updates of committees and etc.

REGULAR MONTHLY AND COMMITTEE UPDATES

1. Planning and Zoning UpdatesDean Coe Steve Yokeley, speaking as Planning Board Rep, said that there had been no business to be conducted at the October Planning Board. He reiterated that the November Planning Board meeting is **canceled**.

- 2. Finance UpdateMark Swaim

 Mark Swaim presented the financial reports for the month. He said the finance committee would be funding some of the funds within the next thirty days or so.

 Mayor Todd commended the finance committee, and Mr. Swaim in particular, for the great work being done with the finances.
- 3. **MPO** High PointLynn Reece
 Lynn Reece, as the MPO-High Point representative, said there had been a meeting on September 22nd but that nothing pertaining to Wallburg had been discussed. He did say that the <u>stimulus</u> money was very much the focus of the meeting. They mostly want to get money for the Yadkin River Bridge. He also mentioned that PART was getting larger buses that will haul more people. On a question of where NC-109 stands, Mr. Reece observed that it was 2nd on the priority list of the <u>High Point MPO</u> but that it could be a higher priority on the Winston-Salem list. Widening Finch Farm Road was #1 on the High Point list. This meeting is a monthly meeting -- meeting the 4th Tuesday of each month.
- 4. Building Committee UpdatesLynn Reece
 As the Town Hall building liaison, Lynn Reece told the council that he had preview maps they could review if they wanted. The architect, John Fuller, has asked for council input and has also requested that a Special Informational Meeting be called to review and discuss town hall building plans.

 After much discussion, the council decided on the date of <u>Thursday, October</u>

 22nd at 5:00 p.m. at the Fire Department for the meeting. Clerk Lynn will send out a Public Notice announcing that date.

 Mr. Swaim requested that, if possible, the council members be provided with the maps, etc., before the meeting in order to review and formulate questions ahead

On a motion by STEVE YOKELEY, seconded by MARK SWAIM, a Special Called Informational Meeting will be held Thursday, October 22nd at 5:00 p.m. at the Wallburg Fire Department to review and provide input for the new proposed town hall building.

5. **MPO -** Winston-SalemMayor Todd Mayor Todd represents Wallburg at the Winston-Salem MPO meetings and the prior meeting was held on September 17th. No projects directly relevant to the Town of Wallburg were discussed. Mayor Todd said the Winston-Salem MPO was doing a good job but that funding is a major issue. Stimulus money was discussed.
