### PROCEDURAL ITEMS

Mayor Allen Todd called the meeting to order at 7:00 p.m. Present were the mayor, Steve Yokeley, Zane Hedgecock, Gary Craver, Lynn Reece, Mark Swaim, Attorney Jay Wagner, and Clerk Lynn McKinnie.

Mr. Hedgecock said a brief invocation while Mr. Yokeley led the pledge to the flag.

Several changes were made to the agenda:

- 1. Mr. Swaim requested Item #2 be deleted as Mr. Larry Morgan of Davidson County Emergency Services was unable to attend. He asked that this item be placed on the <u>June</u> agenda.
- 2. Mr. Yokeley asked that Item #3 and Item #4 be deleted as more information would be needed before a decision on this issue could be made.
- 3. Mayor Todd asked that an item be added to the agenda as Item #2 Davidson County Bulletin for Citizens.

Steve Yokeley moved to approve the <u>amended</u> agenda with Gary Craver seconding – and the council voting unanimously to approve.

## 1. QUALITY ASSURANCE AGREEMENT .....DWAYNE CHILDRESS

Mr. Dwayne Childress, Davidson County, respectfully requested that this item be pulled from the agenda as the representative for this issue was not able to attend the meeting. Mr. Childress said, "I know the town needs someone here that is committed to the project and not just involved. We're still early in the process..... I'm sure everyone has driven by the site and seen the big hole. They're still in the process of erosion control (sediment, water diversion) and so what I would like to know is if any of you have the name of someone, that is local, that could do this work. I would be willing to engage that person and try again next month." Mr. Childress apologized for the interruption in the process and turned the council's attention to the last page of his handout (which was included in the agenda packet). He said there had been a pre-con meeting which he and Lynn Reece attended. The last page gives a little bit of a schedule of happenings through the end of June. There has been a lot of teamwork with the group working on the town hall site. Mr. Childress said, "Just to hammer home what it is that we are working on – and whose money it is we are actually spending – and that would be the public's money." He passed out to the council buttons that read "NO CHANGE ORDERS".

Mr. Yokeley asked what the qualifications would be for someone to do Quality Assurance and Mr. Childress replied:

- 1. Have the experience in doing this type of work; and
- 2. Be a licensed commercial general contractor

Mr. Hedgecock asked what other criteria would be required and the answer was that this person should have at least built a building somewhere at sometime.

Mr. Craver asked how much money were we talking about and Mr. Childress replied, "Less than \$20,000".

Mr. Childress stated that if anyone had suggestions for a candidate, to email him the names, etc.

Mayor Todd said that Mr. Childress was doing a great job and the Town was glad to have him working for us.
