#### 1. Finance Update

Mark Swaim gave the highlights of the financial status of the Town:

Checking \$723,170.83

Building Fund \$940,187.47

Capital Fund \$250,026.02

Reserve Fund \$125,589.61

Money Market \$503,062.25

\$2,542,036.18

Mr. Swaim said that there would be a couple of large checks coming through on the Building fund. He also mentioned that the town auditor has started the audit process.

#### 2. MPO - High Point

Lynn Reece said there was not a meeting this month.

#### 3. Building Committee Updates

Mr. Reece said the process on the town hall was running smoothly. Duane Childress was definitely keeping up with everything! They've filled out around the building – waterproofing. They're trying to decide on the type of phone service. Things are really well coordinated. They're on schedule with their work – some a couple days ahead, some a couple days behing.

#### 4. **MPO -** Winston-Salem

Mayor Todd said that the MPO meeting was held on July 15<sup>th</sup> and mostly revolved around action in the Winston-Salem area – nothing pertaining to the Wallburg area. The Beltway has been put on hold. The I-85 bridge is on schedule to be built. He said that the NC-109 paving – thanks to whoever was responsible for getting it going, the contractor did a great job – it was quickly done. He appreciates very much what has been done on that road. The MPO also discussed bike paths.

# THIS 'N' THAT

- Mayor Todd thanked Gary Craver for all the hard work he has done on the Census taking. Mr. Swaim said the census numbers were going to impact Wallburg, hopefully through the sales tax – it will have an impact on future finances for Wallburg.
- Mr. Hedgecock asked about the information brochure that has been mentioned at past meetings. Lynn (McKinnie) will mail the brochures if mailing labels for all residents can be obtained. The question was asked if a letter informing the residents about the program would be inserted and Mayor Todd replied that he would get a letter together and present it to the council by the next meeting. If approved, this letter would be inserted in with the brochure and would include the website and the town phone number for future questions.
- Mr. Hedgecock mentioned that Caterpillar would be coming and that surely Wallburg businesses would benefit from this company coming so close to the town.
- Mr. Reece said he thinks Sheetz is on "go".
- Jay Wagner said he did attend the North Carolina Association of Municipal Attorneys – thanks, he said, to Wallburg's financing – and he learned quite a bit. He met a few other "city" attorneys and they had legal classes that he attended.
