MINUTES

PROCEDURAL ITEMS

CALL TO ORDER

Mayor Allen Todd called the meeting to order at 7:00 p.m. Present were the Mayor, Council Members, Cindy Johnson, Lynn Reece, Mark Swaim, Steve Yokeley and Zane Hedgecock. The Town's Attorney, Jay Wagner was present.

After an invocation by Councilman Lynn Reece, Councilman Steve Yokeley led the pledge of allegiance.

MOTION FOR APPROVAL OF AGENDA

Councilman Mark Swaim moved to approve the agenda, Councilwoman Cindy Johnson seconded, and the motion passed unanimously.

MOTION FOR APPROVAL OF DRAFT MINUTES

- June 11, 2013 - Regular Meeting Minutes

MINUTES for the above meeting were unanimously approved on a motion by Councilman Lynn Reece seconded by Councilman Mark Swaim.

PUBLIC SESSION

Dean Coe, 482 Motsinger Road, Winston Salem, NC 27107, requested that the town council consider allowing the garbage service trucks to begin collecting garbage earlier in the morning to avoid traffic delays for school buses and traffic commuting to work.

Jeanette Small, 548 Reece Road, Winston Salem, NC 27107 presented the town council with a petition and requested for Reece Road to have a speed limit change on that road.

BUSINESS TO BE DISCUSSED AND/OR ACTED UPON:

1. Councilman Steve Yokeley updated on the town hall park advising that at this time Phase Three is completed. Due to the recent amount of rain the erosion control measures did their job and any areas that may be needed for correction or extra seeding will be taken care of. There will be minor grading for less than an acre to connect when the weather clears and land is dry. When any repairs are completed and the soil is stabilized DENR will be contacted.
