February 14, 2012 – Councilman Hedgecock requested the amendment of page 3, fourth paragraph, to read "a new application to be submitted by Ledford High School and presented by a member of the school staff". Motion made by Councilman Hedgecock to approve minutes with changes, seconded by Councilman Swaim, minutes were unanimously approved with changes determined. February 22, 2012 – By motion of Councilman Yokeley, seconded by Ms. Johnson, minutes were unanimously approved as presented.

- 2. Mr. Swaim introduced Mr. Reid who is representing the Ledford High School Band Boosters. Mr. Reid stated the great need due to a tough financial year for funds to be considered from the Town of Wallburg to help facilitate general budget items such as transportation, equipment and band camps fees for those in need. Mr. Reid would like the original request to be granted. Councilman Hedgecock requested clarification of what the grant would be used for. Previously the grant request was for band camps. Councilman Yokeley stated that the grant should benefit the Citizens of the Town of Wallburg. Councilman Hedgecock requested a re-submission of the grant for approval and suggested that there be a meeting with the Principal at the High School to discuss how the school can be a part of the grant process. Councilman Swaim will set a meeting with the Principal at Ledford High School. The Town's Attorney, Jay Wagoner, suggested that there be a motion made to remove this item from the agenda until the situation is settled. Councilman Hedgecock made a motion and was seconded by Councilman Yokeley. Motion passed unanimously.
- 3. Stacy Sosebee, a social worker at Wallburg Elementary School spoke representing the back pack ministry from Abbotts Creek Missionary Baptist Church. This program assists 22 students each week to have food to take home for the weekend. This program serves the chronically neglected. Tom Bailey from Abbotts Creek Missionary Baptist Church advised that this program is provided through the Labor of Love Ministry which is ran from food donations and also monetary donations as well. Mr. Bailey handed out bags to the Councilmembers to have an idea of what are in the backpacks. The church assembles the backpacks and are then distributed by the school as directed by the social worker. Councilman Hedgecock recommended that any requested funds be ran through a public entity and would like for the social worker to have a conversation with the Principal for the grant to be given to the school. Councilman Yokeley is in favor, but a grant will need to be submitted and put through the proper channels. A motion was made to hold open until a formal grant request is received. Councilman Yokeley made the motion and was seconded was Councilperson, Cindy Johnson. Motion passed unanimously.
