Mayor Todd recognized the Ledford High School students who were attending the council meeting and congratulated them on their interest.

1. ALLRED & CARRICK AUDIT CONTRACT RESOLUTION:

Mr. Swaim addressed this issue by saying that the Wallburg Council has been very pleased with the work Eddie Carrick has been doing. This audit firm's prices are consistently lower than others. Cost is up \$500 this year to \$5,000 but still better than other bids. He recommended awarding the contract to Allred and

Carrick. Mayor Todd reminded the council this is the 3<sup>rd</sup> or 4<sup>th</sup> year they have done the audit and they have done a good job.

### 2. DISCUSSION ON DONATIONS >>ATHLETIC SUPPORT FOR GROUPS

Mayor Todd said the council has received many requests for donations for different things and various groups and last meeting, one was received for the Thomasville-Davidson Legion ball team. Mr. Swaim said a concern was that donations of this magnitude was not figured in with this year's budget but could be in next year's budget. He said it would be great if we could help community boosters or groups, that would be great – but as for individual teams, we need to be careful what we support with taxpayer's dollars. He felt what we support should benefit the majority of the community and not one specific team. His recommendation was to consider something for next budget but not to proceed with any individual support of a team at this time. Mr. Yokeley said he totally agreed with Mr. Swaim - To support an individual team is like sponsoring it. Taxpayers' money should go to the community as a whole.

Mr. Craver said he would be glad to make a personal donation but that he, too, could not go along with spending town's money for that type situation. Mr. Yokeley stated he would like to make a motion to decline this request. Mayor Todd said the major concern for all municipalities is the budget – the state is trying to cut everything they can. There is no guarantee for "X" amount of dollars to come in (taxes). He said the council has done an extremely excellent job of managing the money that has come in. Whatever money is coming to the town of Wallburg is kept in the township of Wallburg and benefits the people of Wallburg. What the town is going to have to do is be mindful and be reserved and research every expenditure.

### REGULAR MONTHLY AND COMMITTEE UPDATES

1. Planning and Zoning Updates .....Dean Coe Mr. Coe said the Planning Board did not have any business so used the April meeting as a workshop and just discussed various ideas. One thing they did talk about is the Town Council does need to appoint two alternates to the Board of Adjustment. The alternates main thing is that should be available to attend a meeting in the event the regular member cannot attend – the alternate does not have to be at every meeting – only when called. The BOA has to have a 4/5 vote - it's not a majority so they must have a full board to conduct business. It does not meet unless it is necessary. Lynn said she would type up an application form and send to website for anyone to download and fill out. That way, there would be a pool of applicants to choose from – people who are interested in attending

2. Finance Update .....Mark Swaim

Mr. Swaim gave a brief financial update on the town's finances.

the meetings.

He then gave a brief explanation of the draft budget for 2009-2010. Revenue will be \$627,500 and expenses will be same. Public Hearing for the community will be at the June meeting. There is no line item for Parks and Recreation – but there could be if the council wanted. He said we will have a reduced budget because of the economy.

3. **MPO** - High Point .....Lynn Reece

Mr. Reece attended the meeting was on April 28<sup>th</sup> but very little discussion concerned the Town of Wallburg. Most talk was about stimulus money. Mr. Reece said Dwayne Childress was taking bids on architects and he should have something for the council to look at on May 27<sup>th</sup>.

**4. MPO -** Winston-Salem ......Mayor Todd Mayor Todd attended the meeting on April 16<sup>th</sup> – and a lot of meetings have been held in Winston this last month – all concerning the stimulus money. Most projects will need to be "shovel-ready" in order to qualify for the stimulus money. It has been extremely difficult to get direction on getting any of this money but it looks like a lot of this money will trickle down to the NC-DOT for road maintenance.
